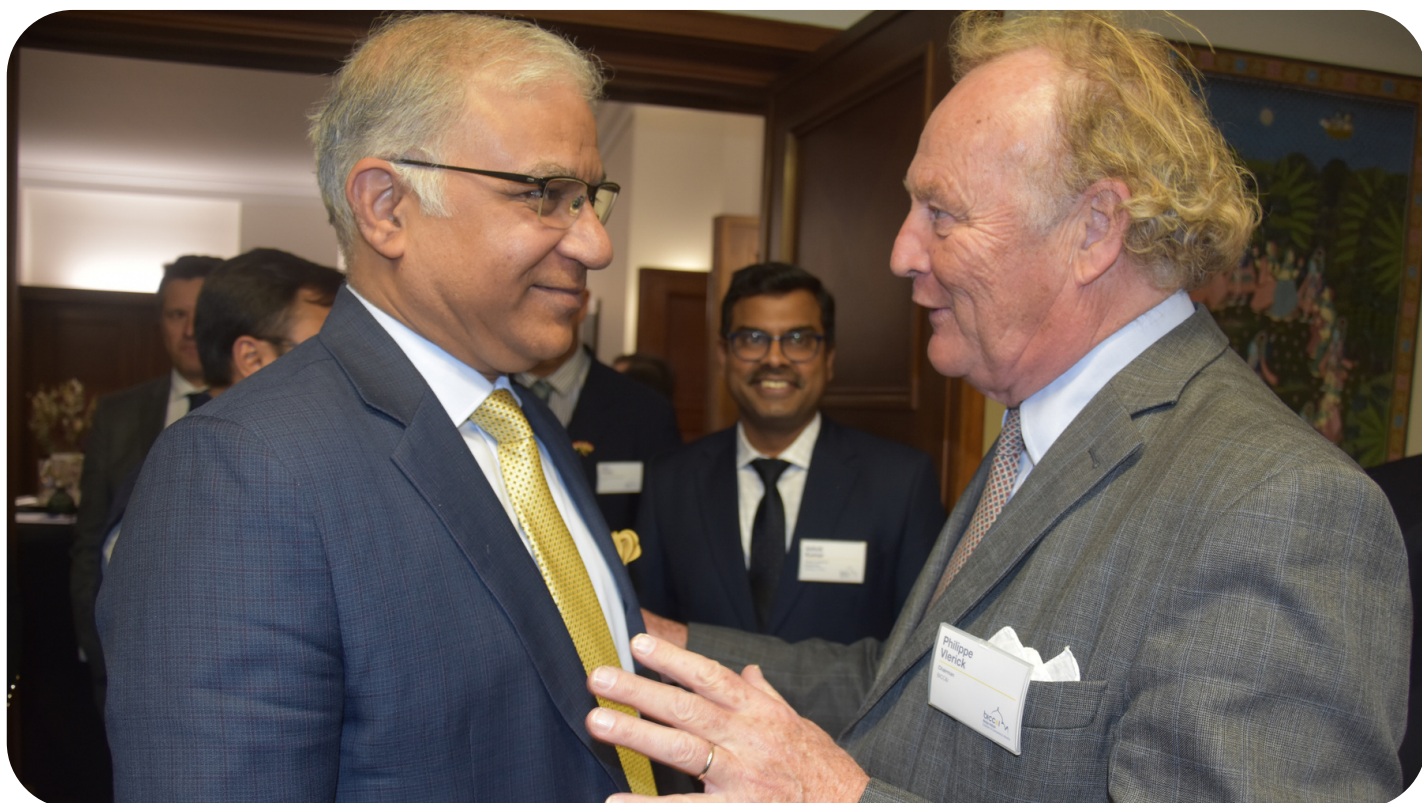

BICC&I New Year Reception – Embassy of India Thursday, February 9, 2023

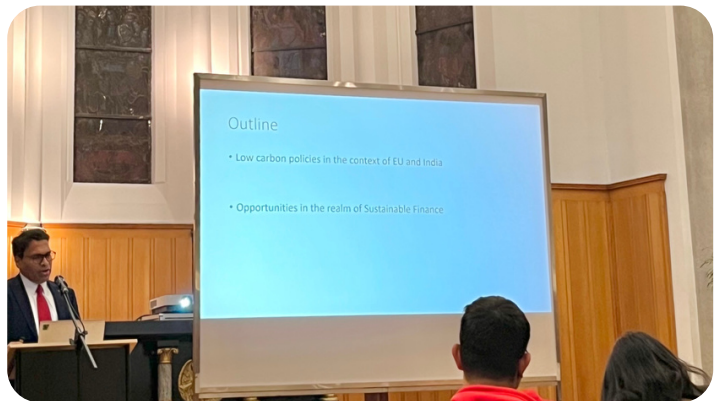
What better place than the beautiful Embassy of India in Brussels to celebrate the kick-off of a new year for BICC&I.

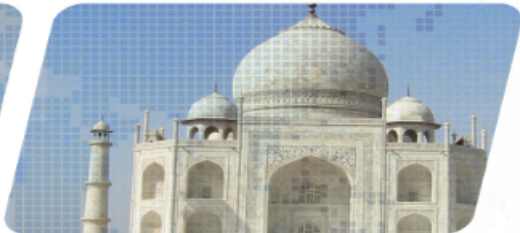




IMT Ghaziabad student visit to Vlerick Business School March 2, 2023

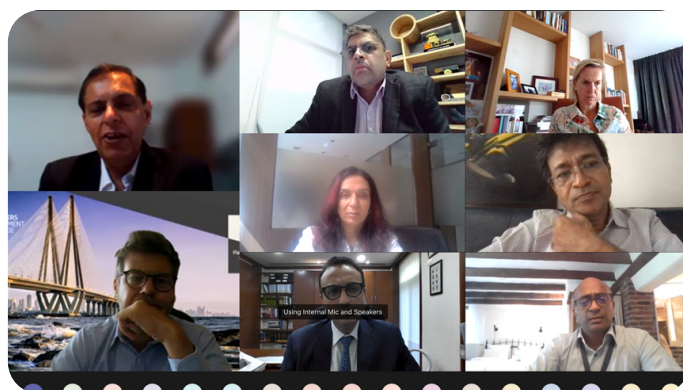


Webinar 'Invest in Maharashtra' in collaboration with Indo-Benelux Chamber of Commerce & Industry in Mumbai June 15, 2023

This yearly event provides a unique opportunity to meet other chambers and to learn best practices from one another.

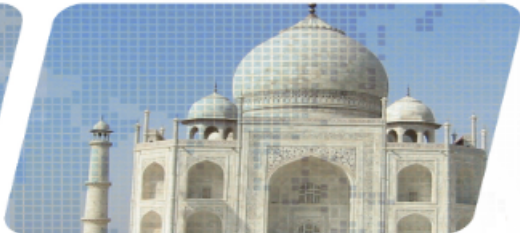




The BICC&I Lunch Causerie – Kasteel van Huizingen September 12, 2023

The BICC&I ‘Catching the Indian Tiger’ event – Minnepoort Theater, Leuven November 23, 2023

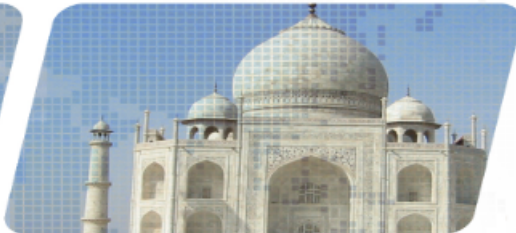

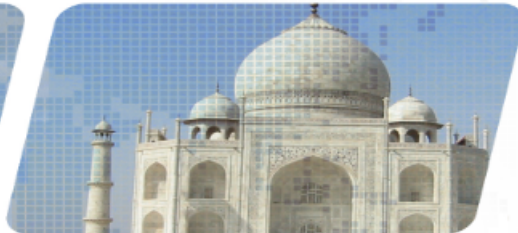

BICC&I also supports educational, cultural and social exchange programmes.

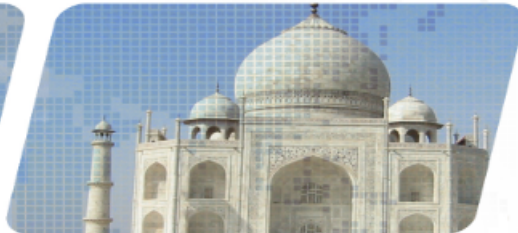
Through its channel and its co-operation with Indian, Belgian and European official institutions, BICC&I serves your businesses in both directions, from Belgium to India and from India to Belgium.
